### **Event overview**

This introduction to chemical compliance for the furniture industry seminar will cover the basics of different legislation applicable across the EU and GB markets that furniture manufacturers and retailers must comply with.

Sessions will cover the background to REACH and UK REACH legislation including information on the European Chemicals Agency (ECHA) and the Health and Safety Executive (HSE - who implement the legislation in the UK). The key parts of REACH including annex XVII - restricted substances - and the candidate list of substances of very high concern (known as SVHCs) will be explained.

Other sessions will also include the Persistent Organic Pollutants (POPs) Regulation and Biocidal Products Regulation (BPR) as well as mentioning other legislation further afield such as Californian Proposition 65.
